The meeting commenced with welcome address by CSE Board chairman Dr.G.Ravikumar, then various items of agenda were taken up for discussion and after detailed discussion, the following suggestions were given by the members of board of studies.

**Regulation 2019:**

- i. The Course "Computer Architecture" may be removed and "Database Management systems" may be introduced in third semester.
- ii. The course "Computer Networks" may be moved from fifth to fourth semester.
- iii. The course "Business and Text Analytics" may be introduced in fifth instead of sixth semester.
- iv. The course "Natural Language Processing" and "Computer Vision" may be introduced in seventh semester instead of "AI & Robotics".

**Regulation 2023:**

- i. The Course "Professional Development" may be introduced in first semester.
- ii. The Course "Discrete Mathematics" may be introduced instead of "Statistics and Numerical Methods" in second semester.
- iii. The Course "Probability and Statistics" and "Optimization Techniques" may be introduced in third and fourth semester respectively.
- iv. The Course "Text and Speech Analytics" may be renamed as "Speech and Language Processing" in seventh semester.

After much deliberation, the following resolutions were passed.

**Item 2.1: Resolved** to approve the minutes of First Board of Studies meeting held on 13.05.2022.

**Item 2.2: Resolved** to approve of Scheme and Regulation for the batch of students to be admitted in the academic year 2023-24 onwards under Regulation 2023.

**Item 2.3: Resolved** to approve the Scheme for Third to Eighth semester under Regulation 2019.

**Item 2.5: Resolved** to approve the syllabi for third and fourth semesters under Regulation 2019.

**Item 2.6: Resolved** to approve the syllabi for the categories Humanities and Social Sciences (HS), Basic Sciences (BS) and Engineering Sciences (ES) for Regulation 2023 under CBCS for the batch of students to be admitted in the academic year 2023-24 onwards.

**Item 2.7: Resolved** to approve the list of examiners and question paper setters.
